UPCOMING 2018 NUHW OFFICERS ELECTION

Over the next few months NUHW will be holding elections for union officers, including president, secretary—treasurer, and the vice presidents who make up NUHW's Executive Board. The NUHW Constitution calls for elections of officers every three years between January and March.

Nominations for all members of the Executive Board are done by petition. This year, the nomination period began on Wednesday, January 31, and will conclude on Wednesday, February 14, at 5 p.m.

The election will be conducted by secret mail-in ballot by all regular, retired, and staff members who have paid dues for January 2018 prior to 5 p.m. on February 14.

Ballots for all contested positions will be mailed on Friday, March 9 and must be received by Friday, March 30 at 5 p.m.

Ballots will be counted in the Emeryville NUHW office on Saturday, March 31 at 10 a.m.

The Notice of Local Union Nominations & Election of Officers was posted by union staff on the official union bulletin boards in Seton Medical Center and Seton Coastside between January 8 and January 14. The same notices were mailed on Wednesday, January 17.

IS SETON ALLOCATING ADDITIONAL HOURS FAIRLY?

Maintaining staffing at Seton Medical Center and Seton Coastside has always been a challenge. Seton needs clear and understandable rules to manage staffing assignments on the floors and at Coastside.

Several members are upset with how management allocated additional hours in recent weeks using "Call-Em-All," an automated messaging service that Seton uses to notify staff of vacant shifts.

Our contract sets priorities for how management should assign additional hours and make call-offs, but Seton has implemented a "fastest to call in" rule when CNAs and LVNs respond to Call-Em-Alls.

In February, NUHW will survey CNAs and LVNs on how the Call-Em-All policy is working. Are people satisfied with the Call-Em-All rules? Are the rules understandable? Is the process easy to follow? Is management making decisions made with transparency and with consistency? What do you know about the rules around allocating additional hours that other hospitals and skilled nursing facilities use? The survey will explore these questions and more.

Be on the lookout for the survey and share your experience and opinions. If you think improvements are necessary, please share your ideas for possible solutions.
