MEET JAKE DOOLITTLE

Jake, a San Francisco resident, comes to NUHW from UNITE-HERE.

He became active in unions as a casino worker, organizing his casino along with his colleagues. Jake served on the bargaining committee, which won a first contract that included free healthcare for anyone working more than 20 hours a week.

For the past three years, he has been working all over California helping to organize other casinos and hotels.



"I'm very excited to be working with NUHW because I deeply believe in worker power, worker rights, democratic principles and transparency," he said. "I'm looking forward to fighting alongside NUHW members at Children's Hospital."

CHILDREN'S TERMINATES EVS CONTRACT; WILL DIRECTLY MANAGE DEPARTMENT

As a result of our united front, management is terminating Children's contract with Crothall Healthcare, the outside management firm that spearheaded the failed EVS Rebid.

Starting in June, Children's will once again directly manage its EVS operations. Management first contracted with Crothall in 2017, convinced it could save money by shedding workers, but two months after the Rebid, it's clear that the hospital is dirtier than ever.



Crothall's departure is a testament to our determination and solidarity. We knew what our hospital needed, and we kept up with the fight, even when hospital management continued to believe Crothall over the very workers who keep this hospital clean day in and day out.

Management had no choice but to back down when we got 1,400 workers, including doctors and nurses, to sign a petition, demanding that no EVS workers lose their benefits from the rebid. Following the rebid, we've been documenting every instance in which sections of the hospital have not been satisfactorily cleaned.

During our first rebid meeting last month, dozens of EVS workers testified about being given assignments that were too much for anyone to do in a single shift. Now Crothall is on its way out.

With Crothall departing, we have to keep the pressure on management until they increase staffing and assign reasonable workloads so our hospital is clean and safe for our patients.

Providence St. Joseph workers launch united campaign

Dozens of NUHW members from six Providence St.
Joseph hospitals — and allies from several nursing unions — launched a coordinated campaign on Jan. 19 to win better contracts and build worker power inside the nation's third largest hospital system.

Providence St. Joseph hospitals are chronically understaffed, and they are dealing with an organization that is dead set on maximizing profits despite its non-profit status.

Eureka workers rally against additional layoffs

NUHW members St. Joseph Hospital Eureka joined with nurses on January 24 to protest additional layoffs at the highlyprofitable hospital just three months after 25 caregivers lost their jobs.

The hospital laid off two radiology technician assistants, which will hinder the department's efficiency, Kyle Glenzer, a technician, told the Eureka Times Standard.

"I worry about the delays in patient care," Glenzer said.
"When you're delayed at the beginning, it all unravels: the exam is delayed, the results delayed, the patients' finding out delayed — it creates a domino effect."
