# **\$18.20 PETITION: WE DESERVE THE SAME** TREATMENT!

In a powerful show of solidarity, we delivered our wage petition to Compass management during our January 12 bargaining session. Signed by a super majority of workers at Fountain Valley, Lakewood and Los Alamitos hospitals, urges Compass to pay us at minimum \$18.20 an hour. Workers from all three hospitals participating in our first "cyber delegation."

This demand comes after Tenet's decision to pay its employees 130% above the minimum wage. Although we are employed by Compass, our work directly impacts Tenet hospitals. Yet we are treated like second-class workers, with low wages and no affordable healthcare benefits. We're working at a profitable hospital during a global health pandemic, putting our own safety at risk to keep the hospital clean and safe. We deserve to be paid the same as Tenet workers.

# LETTERS TO THE CEOS AT THE THREE HOSPITALS

On December 21, 2020, we delivered a letter, signed by your NUHW stewards, to all three Tenet CEOs. The letter urged them to extend the Tenet minimum wage to Compass workers. More important, the letter encourages Tenet to bring in-house the subcontracted Compass workers who work at Tenet facilities. Being employed by Tenet would guarantee better wages, healthcare, and a number of other benefits.

Unfortunately, the CEOs from Lakewood and Los Alamitos have responded that they have no plans to change vendors nor insource these jobs. NUHW's political team is collecting letters of support from our community allies to support our fight for a \$18.20 minimum wage. More details to come
