## MESSAGE FROM THE RN/PRO NUHW BARGAINING TEAM—VOTE YES!

## We urge everyone to VOTE YES on our new contract! We are now on the right path!

Our new contract provides the *highest wage increases* we have seen in years, *eliminated the wage "cap"* that froze the wages of 318 of our coworkers, *created a pathway for RNs* to achieve professional growth and higher income, made *inroads in staffing and patient safety* with new language on break nurses, cancellations and Title 22, *secured our health benefits*, put our *PTO usage in our hands* and made 17 *specific improvements*.

To put this in context, our old union had been representing RNs/Pros at Fountain Valley Regional Hospital for the past 34 years. Over the last decade, our wages and standards fell among the lowest in Orange County. Start rates fell 12% lower than the market rates, with unsafe working conditions, no clarity around our rights when it came to safe staffing ratios, lack of education about our contract rights and no structure to enforce our contract. We had no power.

## Since joining NUHW, we have:

- Built for the first time a representative structure whereby all units/departments now have representation on a daily basis and at the bargaining table
- Hundreds of us have participated in various union activities
- We filed 208 complaints with CDPH launching unprecedented investigations
- Negotiated a contract that greatly narrowed the gaps that UNAC left in its 34 years of union representation

Not only did this contract achieve advancements, it positions us for further improvements in future negotiations, elevates workplace standards and puts management on notice that there is clear unity across job classifications and among the ranks.

We will continue to pursue corrective action plans that address ongoing patient safety concerns and work to empower all of us to advocate for ourselves and our patients.
