Course Content and Instructional Methods: Social factors, including the system of health care coverage, can dramatically affect patient outcomes. Understanding the impact that social structures have on their patients and clients can help health care workers mitigate some of the negative effects. By participating in activities aimed at changing the relevant social structures, health care workers can improve patient and client outcomes. (Lecture, Group Discussion)

She has taught health care workers across the country how to most effectively advocate for their patients the contemporary context. She has served as a clinical social worker for 25 years, most recently at Kaiser Permanente.

She has spent the last six years as the Community Liaison for NUHW, where her focus has been on health care reform on the state and national level.
