

Course Content and Instructional Methods: Psychiatric disorders, when left untreated, pose a serious threat to the well-being and longevity of patients. Health care workers can improve access to mental health treatment through a variety of means, including working together to change their workplaces and the healthcare system as a whole. - Kirsten Quinn Siegel, LMFT, is a mental health therapist at Kaiser Oakland. Ms. Siegel worked alongside behavioral health specialists in Northern California to better maintain the standard of care for patients.
- Kenneth Rogers, PsyD, has 15 years of experience as a clinical psychologist in the Kaiser system, most recently in Santa Clara. He was one of the leaders of a movement to improve access to mental health care and mental health outcomes across the state of California.
