# **BARGAINING UPDATE**

More than 40 members from our SCAH units in Concord/Alameda, San Francisco and San Mateo participated in our latest bargaining session; the majority from Concord/ Alameda. Going into this meeting, management owed NUHW responses on 17 articles.

We reached tentative agreements on the Savings Clause and Jury Duty.

We also dicussed the following articles:

- o **Preamble:** Management agreed with most of our language and management agreed to the "location" vs. "branch" change we proposed. Also, management agreed with our proposal to add "respect" to the last paragraph, as long as we let stand that "this paragraph will not be subject to the arbitration provisions of the grievance procedures." However, management wants a definition of what "dignity" and "respect" in our proposal mean.
- o **Management Rights:** Management wanted to know where the language for the "No Strike No Lockout" provision came from. It came from our California Pacific Medical Center contract.
- o **Seniority and Introductory Period:** Management wanted to know why the union combined two proposals in one. Management thinks they should be separate.
