At their annual celebration recently, North Bay Jobs with Justice honored NUHW as members across the region continue to organize and settle contracts during the pandemic!

"When their employer insisted on cutting health and sick leave benefits during a pandemic, nearly 750 NUHW members at Santa Rosa Memorial Hospital responded with a five-day strike that galvanized public support for essential workers and revealed the misplaced priorities of Providence, the hospital's out-of-state corporate owner. During the fight, frontline



caregivers testified to major issues at the hospital during a Workers Rights Board hosted by NBJwJ. In addition, NUHW organized healthcare workers at Sonoma County Jail, secured


our allies, we can do so much more! When we build a strong foundation from the bottom-up, it creates success for everyone." - Taylor Davison, ER Registration

a contract at Petaluma Valley Hospital, and settled a first contract at Queen of the Valley Medical Center in Napa that provided for substantial raises and job protections for workers who fought for years just to get management to the bargaining table. NBJwJ was proud to stand with NUHW caregivers at each of these facilities!"

WHEN WE FIGHT, WE WIN


Enforcing our contract and holding management accountable!

Our coworkers in EVS have recently won several grievances where unjust disciplinary action for 3 of our caregivers was rescinded!

STEWARD SPOTLIGHT: SEAN TAYLOR



"I wanted to get involved during the contract negotiations because Providence starting off trying to remove our PPO was unacceptable and immoral, especially when their EPO plan leaves gaps in care for our members and their families.

I decided to stay involved because Providence wanted takeaways that weren't just or compassionate, and didn't recognize our dignity. I couldn't stand by and condone it, which is what staying quiet and not getting involved would have meant: "All evil needs is for good people to do nothing."

We have far too many managers and executives who ignore our concerns, and therefore deny our patients the excellence of our care we know we are capable of providing. They act without integrity when they ignore our never-ending short-staffing while focusing on profits over patients, despite massive profits. They deny us justice from oppression when caregivers are subjected to verbal and physical violence from management.

Integrity requires that WE act to hold Providence accountable, that WE do the right things for the right reasons and speak truth with courage.

Walk with me and my fellow stewards. Let us improve our working environment by enforcing our contract. Help us treat one another with dignity and compassion each and every one of us deserve. Let us lead with the core values we so rarely, if ever, experience from our managers and executives."
